OF ALL THE fruit-growing districts of the Northwest there is no doubt that Hood River is the best known. It is known not only for its fruit, but for its beautiful scenery, its enterprise and the high class of its citizenship. As a place to live, from the viewpoint of climate, educational facilities and other features that combine to make an attractive home life, with rapidly developing business opportunities, it is probably not surpassed by any section on the coast. Little known and undeveloped twelve years ago, it has today property with an assessed valuation of over \$6,000,000.

As to its situation, Hood River is the county seat of Hood River County, a new county created July 1, 1908. It is sixty-five miles east of Portland on the Columbia River, and has a population of 8,000 people.

Three thousand of these are in the hustling little modern city and the other 5,000 are scattered throughout the valley of 50,000 acres. The city is electric lighted, has good water and sewer systems and superior educational facilities. Situated on the main line of the Harriman system of transcontinental railroads, it has both river and railroad transportation.

It is estimated that the valley has 10,000 acres under cultivation to orchards. Its fruit products in 1910 are estimated to reach \$800,000, and from lumber fully as much.

Over its entire length of thirty miles is a telephone system, giving every rancher and every city resident as well the benefit of its service. Electric light has been extended into the valley, and rural mail routes give residents out of town a daily mail service.

The Mount Hood Railroad, recently constructed, covers the entire length of one side of the valley, and it is anticipated that a short time must elapse before an electric railroad will be put in operation, constructed for transporting the great fruit output that in five years is estimated to reach 2500 cars. What is known as the upper valley comprises a rich farming and fruit country. During the summer months automobiles are put into service between Hood River and Cloud Cap Inn, 7300 feet above sea level. This resort is one of the most famous on the coast, and is the starting point for tourists who make the ascent of Mount Hood. Another point of great scenic beauty is Lost Lake, visited by many sightseers.
