## IMAGE USE AGREEMENT

The History Museum of Hood River County (HMHRC) has a significant collection of research and photographic materials and makes reproductions available for purposes of research, publication, and other uses. Prior written permission must be secured from the HMHRC for any use of reproductions. The HMHRC does not necessarily hold copyright to all the materials in its holdings. In some cases, it may be necessary to seek additional authorization from the copyright owners.

Permission is granted for one-time use only as outlined below:

- Permission is not transferable.
- Use fees are calculated according to specific use.
- All reproductions must be credited to The History Museum of Hood River County with proper citation to the image name, collection number, and original place of publication if applicable.
- All changes to the original image, such as significant cropping, tinting, digital alteration, must be indicated in the accompanying caption.
- Maximum resolution for Web site usage is 640x480 pixels.
- Web site usage requires a credit line (per above) on the same page as the image.
- User assumes all responsibility for possible copyright infringement and invasion of privacy arising from the use of reproductions.

### **Rights and permissions for photo use vary by type of use.**

**Personal Use** means the use of a photograph for personal, non-commercial purposes, such as wall display in a private residence and personal genealogical research. No other rights are granted.

**Reference Use** means using a photograph in scholarly research, but does not include publication. No other rights are granted.

**Commercial Use** means using a photograph in a commercial application, such as advertising, scholarly and commercial publishing, and commercial display. Rights are granted after payment of the Usage Fee. Rights are described in the Application for Permission to Publish Form.

### **WARNING CONCERNING COPYRIGHT RESTRICTIONS:**

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction.
